



As of 31 August 2018, Ethiopia hosted 905,831 refugees, 50.2% of them girls and women. The Majority came from Sudan, South Sudan, Somalia, Eritrea

80,748 female refugees are enrolled in formal education within and girls centres in five field and outside of the refugee camps in Ethiopia.

There are a total of 35 women operations across the country.

HIGHLIGHTS

- Community based Complaints Mechanism (CBCM) for Protection from Sexual Exploitation and Abuse (PSEA) is operational in camps under Sub-Offices Melkadida and Gambella. Refresher training in both locations are ongoing to enhance the multiple reporting mechanisms. The same mechanism has been established in Addis Ababa, while work is underway to operationalise CBCMs in the rest of the refugee-hosting locations in Ethiopia.
- Gender-based Violence Information Management system (GBVIMS) is functional in most of the locations in Ethiopia. GBVIMS aims at enhancing data collection, storing and sharing in an ethical manner. As part of the efforts to enhance GBVIMS data analysis, UNHCR is organising a series of webinars to enhance staff capacity.
- SGBV mainstreaming across different sectors is a priority in the Ethiopia refugee operation for which SGBV risk analyses are being conducted to support relevant efforts.
- The National CP/SGBV Sub-Working Group has endorsed the Guidance Note on Responding to Sexual Violence against Males and Engaging Men and Boys in Preventing Sexual and Gender-Based Violence. These key interventions aim at raising awareness among different SGBV actors and share tips on how to ensure the inclusion of men and boys in SGBV programmes as survivors of SGBV as well as key actors in preventing and responding to it.
- Refugee communities together with protection actors are working hand in hand to protect children from harmful traditional practices. Anti-FGM groups were established in Melkadida where facilitators were trained on consequences of FGM to support in leading dialogues with the community on FGM.




- Strengthen capacity of community based structures to prevent and respond to SGBV
