

#### SITE UPDATES

#### Wau PoC Site and Collective Centers

Wau PoC 171 Wau PoC AA 25.155 Collective Centers 15.887

- On 8 March, CCCM and Displacement Tracking and Monitoring teams conducted a population fixing exercise across five internally displaced persons (IDP) sites in Wau, including the protection of civilian (PoC) site. Around 180 staff from seven UN agencies and non-governmental organizations took part, distributing approximately 34,000 tokens to IDPs eligible for biometric registration.
- From 13 to 19 March, Camp Management and DTM conducted the first biometric registration of the Wau PoC site population, registering 25,155 individuals (6,199 households). Registration activities will now start in the collective centres with Camp Management working with DTM to prepare the sites.

#### **Bentiu PoC Site** Bentiu PoC 117,654

- Camp Management held the first youth forum meeting, which brought together 12 youth groups in the PoC site. Through this forum, all youth groups will be represented in meetings and discussions on issues affecting the youth. Camp Management will conduct a monthly mapping exercise to identify any new groups that are formed and incorporate them into the forum.
- Camp Management conducted two mass sensitization campaigns to inform the IDP population about the International Women's Day celebrations taking place in the PoC site on 13 March. Camp Management coordinated with psychosocial support partners to incorporate a drama group in the messaging and engage the community, permforming a play to highlight the specific vulnerabilities women face in the PoC site.

#### Melut PoC Melut PoC Site and Displacement Sites Displacement sites 26,516

• Camp Management conducted a major sensitization campaign reaching men, women and children to inform them of key issues affecting the safety of children in displacement sites. Some of the key messages conveyed were that parents should ensure that their children do not bathe in the Khoradar stream and that their children do not play around the drainage, disposal pits or in the road.

**Bor PoC Site** 

Bor PoC 1.956

- The UN Special Representative of the Secretary General (SRSG) visited the Bor PoC site on 10 March and met with various members of the community. IDPs had the chance to ask questions and raise their concerns regarding the conflict and the peace agreement.
- Following community threats against Camp Management and a Protection partner staff member, Camp Management closed the information desk, reduced the movement of staff in the PoC site and paused site maintenance work and the recruitment of casual labourers. Following a general meeting whereby the community provided a written guarantee of staff security. Camp Management has since resumed activities, and the community will present their summarized complaints, including around the issue of casual labour recruitment and different sectorial complaints, in a formal letter, to be addressed by Camp Management and partners.

#### Juba UN House PoC Sites

UN House PoC 1 and PoC 3 38,833

• There has been a significant number of new arrivals in the PoC site since the late December period with Camp Management continuing to register new arrivals into both PoC 1 and PoC 3. Rehabilitation work on the International Medical Corps clinic in PoC 3 continues so as to resume health services to the population.

#### **Malakal PoC Site**

Malakal PoC 30,559

 Camp Management is installing 40 solar street lights in the PoC site. Community leaders and women have raised concerns regarding people vandalizing the lights and other communal infrastructure. Camp Management conducted an awareness raising campaign through the Internews Radio to inform the community of the importance of community ownership of the communal facilities.
