1. Welcome, introduction and review of the action points of the previous meeting

The TWG Coordinators welcomed participants and explained that, in this occasion, it was important to conduct this meeting in Ankara in order to have an opportunity to discuss with chairs of sectors and WGs issues related to CBT across the sectors, particularly, on the reporting of several types of cash assistances. CBI TWG members based in Gaziantep, were requested to join via Skype or asked to request their Ankara colleagues to attend on their behalf.

WFP revisited the action points from the previous meeting, as follows:

TWG coordinators to share the revised 2018 CBI-TWG Work Plan with members for final

- review and comments. Status: Completed.
- WFP will work on draft of an online survey to collect information on CBI programs and modalities across all the sectors. Status: Completed. TWG coordinators have developed a draft of an online survey/4Ws to collect information on CBI programs and modalities across all the sectors. The hard copy of the draft was shared and further discussed under AOB.
- Nomination of an NGO partners as a Technical Advisor. Status: The call for nomination was circulated among partners and given that no feedback was received, TWG coordinators asked CARE for an extension on this role. This was further discussed under AOB.

2. Presentation of CBI TWG Decision Tree in Turkey, followed by discussion with sector leads

- The decision tree is a tool developed by IOM with technical support of the CBT TWG as a tool for partners
 to determine whether cash-based interventions were applicable in specific contexts in Turkey. The tool
 was presented in the CBI TWG meeting on July, 2017 and further improved by IOM based on the
 feedback received from partners.
- IOM made the presentation of the latest version of the decision tree and provided a general explanation of its components. IOM also indicated that this is a live document and can be updated/improved based on needs and/or relevant feedback received from partners.
- The tree also contains the link to CBI-related Protection Risk Matrix. As it wasn't possible to access the link during the presentation, IOM will check and update it.
- WFP highlighted that the preparations are underway to introduce homecare assistance for disabled people under ESSN and once launched, it can be feasible to consider it within the tree.

Action Points:

- TWG co-chairs to circulate the link to CBI Decision tree and CBI Protection Risk matrix among the partners. Deadline: 28 February 2018.
- IOM to continue amending the CBI decision tree based on comments/feedback received from partners. Deadline: Ongoing.

3. Brief introduction of CBI in different sectors followed by discussion with sector leads

- UNHCR made a presentation on globally accepted cash-based interventions across the different sectors.
 The presentation highlighted the importance of combination between cash interventions and durable solutions programs to achieve ensuring of protection mandate of humanitarian activities. Examples of different possible CBI-related activities across the sectors/clusters were presented, including:
 - Protection, where the cash interventions may include participation in protection-related awareness related programs; safe housing; specific needs; reintegration/reunification; legal support; etc.
 - Education, where activities may focus on access to early childhood, primary, and higher education; promotion of access to education for girls and women; language; etc.
 - Shelter, which includes protection from whether elements, renting assistance, NFI, CfW, transitional shelter, etc.
 - Livelihoods, where CBI may be applied for provision of financial and productive assets, vocational trainings, CfW, legal support, etc.
 - Health, which may include provision of cash assistance for health for insurance premiums, cash to adolescent girls, targeting reduction of early pregnancies and HIV transmission, family planning counselling, and other.

- Presentation also covered activities that are likely applicable under CBI depending on the context as well as interventions which are not compatible with CBI.

4. Discussions around reporting of CBI in 2018

Based on request received from BN WG to provide recommendation/technical advice on remaining
confusion in relation to certain Cash reporting (e.g. in relation to Emergency Cash which may be used to
cover shelter, medical expenses, transport, etc.), WFP presented the Overview of CBT-related indicators
under 3RP/2018 across the different sectors in Turkey to initiate the discussions around the reporting
of CBI in 2018. The indictors possibly relevant with CBI were reviewed as follows:

5. AOB

a) CBI online mapping exercise:

- TWG co-chairs shared the hard-copies of developed a draft-tool for an online survey to collect information on ongoing CBI programs in Turkey. It was highlighted that the results of the survey will feed into a CBI mapping exercise. Partners and leads of all sectors were asked to provide their comments/inputs on the questionnaire once it is shared with them.
- Partners proposed to include a section on Emergency Cash to find out the scale of interventions under this category and further discuss where they should be reported.

b) Nomination of Technical Advisor for TWG

- As no nomination was received from partners, CARE accepted to continue covering this role until a suitable candidate comes along. TWG coordinators and partners took this opportunity to thank CARE and Salah Hamwi for a job well done and their good disposition to continue in this role.
