




Support to Public Institutions by the 3RP in Turkey

2019-2020 Key Findings

This factsheet presents the third edition of the public institutions support tracking, focusing on progress by 3RP partners in 2019 and 2020. The tracking of support to public institutions aims at evaluating the evolution of the response in Turkey towards more support to national systems and to inform global processes as well as pursue synergies with other frameworks such as the new National Development Plan 2019-2023.

The analytical framework looks at the 3RP support provided across sectors and agencies to public institutions (Ministries, Public Agencies, Local Authorities such as municipalities). It refers to 3RP programmes where public institutions are the primary beneficiary and retain the support provided, whether in the form of additional resources (equipment, staff, new infrastructures) or in the form of system strengthening (training, technical support to set up procedures or develop policies). data on support delivered through public institutions, notably cash transfers, is also collected to document the use of public systems to reach refugees and host communities.

The data used in this report has been collected directly from 3RP partners who provided financial data and programmatic details on their respective support to institutions in 2019 and plans with secured funding for 2020.




- The findings confirm that the 3RP continues to increase its support to public institutions across years.
- In 2020, 3RP partners have secured USD 217 million worth of support to national and local institutions.
- This represents a 20% increase from the support provided in 2019, which totaled USD 178 million.
- Since 2017, the support to public institutions by 3RP partners has increased by nearly a third.
- In total, since 2017 3RP partners have been providing USD 712 million worth of support to public institutions in Turkey to expand, improve and strengthen services and assistance to Syrians under temporary protection and their host communities.






- Support to public institutions includes both significant investments in public infrastructures, facilities, and staffing capacities (USD138 million in 2019 to increase to USD 167 million in 2020) and also in strengthening public systems through capacity and policy development (USD 40 million in 2019, to increase to USD 49 million in 2020) which are critical to deliver assistance to refugees and host communities and also to ensure sustainability of efforts.
- In addition, 3RP partners have been using national systems to deliver assistance support delivered through institutions amounted to a record USD 575 million in 2019, and is expected to decrease to USD 233 million in 2020 notably as the Emergency Social Safety Net Programme is now being delivered outside of the 3RP.




- The Ministry of National Education has been the main institutions supported by 3RP partners, and is expected to benefit from a further increase in support in 2020, with USD 133 million channeled to assist the ministries in providing education services to refugee children.
- However, the 3RP continues to provide support to a comprehensive range of institutions, from the Directorate General of Migration Management which oversees the refugee response in Turkey to Chambers of Commerce and Industry and local municipalities on the ground. The comprehensive nature of the support provided by 3RP partners has been maintained in 2020.
- The comprehensive approach from the 3RP partners maintained and increased the full range of public institutions which increasingly channeled and delivered. Although the decrease of support through public institutions, it has not led to a decrease of support to the capacity of public institutions. The 3RP remains critical role to strengthen national systems in order them to absorb assistance and deliver effectively.











Evolution of 3RP Support by Institution since 2017


