





Estimated decrease in arrivals in Europe via the Mediterranean and Canary Islands routes in 2020 vs. 2019

In total, sea arrivals in Europe via the Mediterranean and Canary Islands routes decreased by 23% in 2020 compared to 2019. However, the routes saw significant variation compared to last year, with an 84% decrease in sea arrivals in Greece in 2020, amid the growing number of reports on alleged pushbacks. Meanwhile, arrivals in Italy almost tripled. In Spain, while sea arrivals in the mainland decreased, there was a significant increase in arrivals in the Canary Islands.

While States generally preserved access to territory for people seeking international protection, an increasing number of credible reports about pushbacks at European borders, as well as some States' invocation of COVID-19 prevention measures to limit access to territory, affected the arrival and movement of asylum-seekers and refugees.

Spain was the primary entry point to Europe for those traveling along the Mediterranean and Canary Islands routes in 2020, receiving some 41,900 arrivals by land and sea. Of these, 55% arrived in the Canary Islands. Overall, most of those arriving in Spain were from Algeria, Morocco and Mali. In 2020, at

least 809 people perished at sea while trying to reach Spain along the Mediterranean (41%) and the Canary Islands routes (59%).

In 2020 in Italy, most arrivals had departed from Tunisia (43%), Libya (38%) and Turkey (12%). Persons arriving from Tunisia were mostly Tunisian nationals, while Bangladeshis comprised the largest group arriving from Libya. Crossings from Turkey to Italy increased in the latter half of the year, mainly composed of Pakistani and Afghan nationals.

Greece reported the arrival of 9,700 people by sea in 2020, with Afghans and Syrians remaining the two primary groups, despite the significant reduction in overall sea arrival numbers. As in previous years, more than a third of those arriving by sea were children. The Turkish Coast Guard reported having rescued or intercepted some 20,400 people in this period, many of whom had allegedly been pushed back while attempting to reach Greece.

SOUTH EASTERN EUROPE⁶

As part of mixed movements, in December, 1,701 persons arrived in the subregion, a 52% decrease compared to November (3,573) and a 53% decrease compared to December 2019. Overall, 2020 saw lower numbers of arrivals during winter, consistent with trends in previous years. An estimated 52,475 people arrived in or transited through South Eastern Europe in 2020.

In December, 180 persons submitted an asylum application across all countries in the subregion, for a total of 4,633 asylum applications in 2020. Eight new positive first-instance decisions (five refugee status and three subsidiary protection status) were issued in December. In 2020, 36 persons were granted refugee status and 49 persons subsidiary protection status across the subregion, while 176 applications were rejected. Serbia granted the highest number of refugee status decisions (17), followed by Kosovo (S/RES/1244 [1999]) (11), Montenegro (7) and Bosnia and Herzegovina (1). Meanwhile, Bosnia and Herzegovina issued the most subsidiary protection status decisions (28), followed by Serbia (12), Albania (4), Kosovo (S/RES/1244 [1999]) (3) and North Macedonia (2).
