3. UNHCR Gender & Age Map

The UNHCR Ass. Data Management Officer introduced the new gender and age map created by UNHCR benefitting from GIS capacity and availability of data to support the need to better understand and communicate the situation of persons of concern [PoC] registered in Jordan according to their gender, age and with specific needs. This map also provides detailed information on PoCs' country of origin and their location in Jordan by governorate, while showing the percentage of the population of each age-sex group.

4. Gender Monitoring Dashboard

The UNHCR Information Management Officer presented to the Network the Gender Monitoring Dashboard template along with its reporting guidance. The dashboard template aims at showing the level of implementation towards the gender agenda for each sector of the regional response to the Syria crisis in Jordan. The presentation started with the reporting guidance of the dashboard template whereby the main source of information to be used for filling the template is presented as well as where technical support can be found. The presentation went on and the dashboard template itself was shown to the gender focal points, and the relevance and the filling of its sections detailed. The timeline of reporting has also been communicated to the meeting participants and the challenges of the availability of the response data discussed. The tentative reporting has been set to the second half of July 2021 when better data is present in the ActivityInfo monitoring databases.

Questions raised from the presentation covered the areas of: filter enhancement of the sector online dashboards for better progress tracking between what was planned and what's being actually achieved; possible extension of age coverage for targeted interventions to specific population identified based on the vulnerability linked to their age.

5. Updates from SGFPs / Sectors [progress against individual workplans and gender activity plans with sectors]

GBV Sub-Sector [UNHCR and UNFPA]:

The GBV SWG Co-chairs briefed on the guidance note for GBV prevention and response in COVID-19 vaccination centers developed by the SWG. The document highlights the need of disaggregated data based on sex and age of individuals who received the vaccination. It also provides key messages to emphasize on women and girl's participation in decision making, GBV services and PSEA. The GBV SWG launched this document in the occasion of World Refugee Day. The WGs at the field level conducted a couple of sessions to disseminate it with the key messages in coordination with health sector. IOM has also produced posters with the key messages, and they will be ready soon for dissemination.
