



CCCM Partners will advocate that all sectoral gaps at IDP Hosting Sites with any service providers as NGO ,INGO, Benefactor etc, In order to cover the dire need at IDP Sites. CCCM SNCC will hold meeting with WASH SNCC in order to get feedback about if there any service





providers or agency that has the capacity to provide or supply IDP Sites by water.

Deem Coordinator will visit the water foundation regarding water need issue.

ABC will send an email to CCCM SNCC regarding the intervention of UNICEF at IDP Sits by provided latrines without coordinated with CCCM Partners.

ABC will monitor and following up the affected IDP Hosting Site Same'a Stadium by flood with Shelter and Protection Partner in Taiz Governorate.

CCCM Partners will holding meeting with ABC lbb in order to discuss the challenges at IPD Sites.

CCCM Partners will hold meeting with Zaid RRM Coordinator in IBB area in order to discuss with him the mechanism of coordination at IDP Hosting Sites.

YWU will conduct assessment for 6 HHs at Ahwal Ramdan Site that threatened at the risk of eviction.

	 IOM. IOM CCCM Team Leader clarified and confirmed that most of IDP Hosting sites get mitigation of flood by building the retaining wall and implemented maintenance activities at sites which related to protect IDPs from flood or torrential rain. Furthermore, he mentioned that IOM has distributed sandbags across IDP Hosting Sites that under its management. YFCA. YFCA has raised flood report and escalated three of IDP Hosting Sites that affected by flood two of them Alwadah Center and Ahwal Alagouz site get response and Same'a Stadium did not get response in spite of the escalated this issue. In addition, At the most of IDP Hosting sites that are in low and high risk have get some mitigation response as leveling ,establishing channel among tents ,building retaining wall and distributed sandbags based on the flood response and gaps at sites. Proportion 80% of maintenance(Flood response) has achieved. Deem. Mr. Sameer has confirmed that all IDP Hosting Sites that affected by flood have conducted need assessment in maintenance including that flood response.
