



GBV Referral Pathways and Service Mapping

- Need to update information and finalize Referral Pathways until May 2023 (last update of May 2023)
- Suggested format for Referral Pathways to be changed from current excel format
- Feedback from members on template and amendments
- Follow up and population of Referral Pathways to be led at sub-national level
- Need to include information on: specialized child survivors' services, CMR and other specialization by agencies
- Service Mapping: IM and sector coordinators to review list of services to be shared with GBV WG



Presentation of ActivityInfo Q1 reporting (LCRP and ERP)

- LCRP reporting: need to discuss challenges on reporting
 - > Indicators seem to be complex to report on
 - Need to develop guidance note
 - ➤ Need to review the M&E framework
 - > Review of challenging indicators and amendment of 3.1.5
 - New Dashboard to be developed
- ERP: database for reporting not yet open
 - ➤ feedback on reporting was sent to OCHA; partners to collect reporting and then to report retroactively



Client feedback Survey

- New reporting under AI on satisfaction surveys: 3 agencies have existing tools including the GBV IMS+ client feedback survey
- IA GBV WG tool is finalized Q23 is indicating feedback
- Figures reported on client feedback survey use Q1: 23 total
 - January: 11
 - February: missing data
 - March: 12
- Translation to be undertaken
- Agencies so use KOBO to develop an online system
- No reporting on case management staffing




GBV Case Management Gap Analysis

- 7 case management oragnisations participated in a brief assessment on the GBV case management status and gaps in Lebanon
- Average caseload per case worker as reported by the GBV case management/ GBVIMS organisations ranges between 25 and 30 cases
- Due to funding limitations, some organisations recruit case workers that aren't fully deployed to provide GBV case management services. They provide, in addition, CP case management services, protection and access to justice/ rule of law.
- Case management organisations are receiving high number of referrals from Palestinian camps in Lebanon and they are able to serve low percentage due to funding issues/ donor requirements
- Organizations are prioritizing the case management service for medium and high risk cases due to limited resources (# of CW, budget), while the low risk cases are usually referred to FPSS and vocational trainings or transferred to other organizations able to provide the service
- Case management organizations have budget limitations in relation to the case management and GBVIMS/ Primero trainings and any other case management related capacity building initiatives (working with LGBTQ+ survivors, people with disabilities, caring for child survivors of GBV, MHPSS and case management, etc)

GBV Case management analysis


In 2022, Beirut and Mount Lebanon followed by Bekaa reporting the highest percentage of cases/incidents of GBV, while Tripoli reports the lowest percentage

Figure 1: GBVIMS Incidents in 2022



The preliminary findings show that the average number of case workers deployed by the GBV CM organisations in Bekaa is **3**, Akkar **4**, Tripoli **5**, Beirut/Mount Lebanon **4**, and the South **9**
