

GBV Field Working Group – Za’atari

Thursday, March 27th 2014 @ 11:30 – UNHCR Meeting Room Za’atari - Minutes

Participants: IRC, UNHCR, NRC, SCI, REACH, UNICEF, IRD, IMC.

- a) **Updates from CP and GBV meeting** – On Wednesday March 26th the GBV and CP working group leads met in Amman. The chairs together with the GBV/CP working group members agreed to schedule a CP/GBV meeting on April 10th at 11.30 am in the Za’atari base camp. The meeting will be an opportunity for the members to come together, review group initiatives and areas of focus and discuss 2014 way forwards;
- b) **GBV mainstreaming - the focal point system:** Limited presence of GBV focal points at the district levels limits potential for GBV mainstreaming, challenges access to actionable information and hinders potential for effective GBV prevention and response. To fill in the gap the members agreed to establish a GBV focal point system (See Annex). **Action Point:** Members to review the GBV focal point system and TOR, confirm appointed focal points, allocate missing focal points, and start attending district meetings. Inputs and reviews for final endorsement to be shared with the CP/GBV co-chairs by Tuesday April the 8th.
- c) **Safety Audit follow-up - WASH and REACH:** Safety audit presentation continues. Safety audit presented and validated by the CMC, Protection and WASH Sectors, and community mobilization taskforce. WASH sector started developing a matrix and action plan based on safety audit recommendations. Recommendations are also being used to guide discussion on WASH interventions in Azraq. To monitor progress over time REACH developed a weekly monitoring tool covering all WASH facilities. Areas of interest include but are not limited to lightening, sanitary and waste disposal and centre specific details. REACH also agreed to support the working group in collecting info for the next safety audit and to share with GBV/CP working group existing info on distances between existing toilets and population density per district area. **Action Point:** REACH to share with GBV/CP co-chair weekly findings. REACH findings to be incorporated in the next safety audit (qualitative and quantitative info to allow better analysis). GBV/CP to ensure REACH is informed on next safety audit timelines and developments. REACH to share with GBV mapping of existing toilet facilities and related population densities.
- d) **AOB (SCI - sites relocation)** – SCI supported by UNICEF informed the group on proposed changes for their 2014 interventions. Changes were endorsed and agreed by the group members including locations: a) *to be closed* (Y1, Y2 and Y3 in districts 10, 9 and 6 and CFSs B, P, H and K in district 2, 8, 10 and 11), b) *to be expanded:* CFCs R, M and F in district 8, 10 and 12 with 2 additional CARVANs, c) *to be relocated* (CFS 'D' in district 1 transformed into Drop in Centre for children in labor), c) *new locations (MACs):* district 5 (for male) and district 7 (for female).
